RENTAL AGREEMENT

The agreement for a car rental is between the person(s) who appears at the time of rental and signs the separate rental contract as the renter.

If you agree to comply with the terms, both printed and written, below and on the separate rate rental contract signed by the renter, which are incorporated herein, receipt of which you hereby acknowledge (collectively referred to as the "Agreement").

Taricita Hunt Car Rentals hereby leases our vehicles to the undersigned renter, upon the terms set out. The renter agrees to use the vehicle for personal transportation ONLY, and not a loan or sublet. The renter further agrees to indemnify the owner for any and all costs of any damages to the vehicle. Licensed driver must be twenty-five (25) years and older and must have a driver's license for more than two (2) years. Additional driver is thirty dollars (\$30) a day.

All Authorized Drivers are jointly and severally liable for the obligations under this Agreement. We hereby agree to:

1. If an accident occurs the customer names above is responsible for repairs or replacement plus loss of use.
2. The vehicle is property of Taricita Hunt Car Rentals, and is in good condition.
3. The customer will return vehicle in the same condition and running order as when received, to the place and date specified or sooner if demanded by the owner.
4. The vehicle will be returned with gasoline gauge reading the same as when rented: if less then customer will pay difference upon delivery.

5. Under no circumstances shall the vehicle be used, operated or driven,
 - a. In any race test or contest;
 - b. In an abusive manner on the streets;
 - c. By no one else, except persons named in this contract
 - d. By drivers under 25 years of age;
 - e. In excess of specified speed limit.
 6. Customer will report all vehicle violations and will promptly pay all fines, penalties, and forfeitures imposed for parking or traffic violations while the vehicle is held, used operated or driven pursuant to this Rental Agreement, and will be responsible for all such claims arising out of such violations.
 7. Strictly responsible for all damaged plus the loss of use.
 8. The owner is empowered to withdraw this vehicle at anytime if the customer is found in violation of the codes above or road traffic laws.

- We do not accept cash.
 - We do accept Credit Cards.
 - Vehicle must be returned with the same amount of gas as was given at pick-up.
 - Vehicle must be returned in the same condition. Any damage rendered to the vehicle such as scraps, mashes, or any damage at all will be charged to the customer.
 - If vehicle is returned after expected time, customer will be charged for an extra day.
 - An agreement form is to be filled out and signed by driver of the vehicle, this form states that the driver is responsible for vehicle while in his/her care.
 - Remember to drive on the left side of the road.
 - Driver must be a holder of a valid driver's license.

RENTAL PAYMENT DEPOSITS

We require upon or before arrival full rental payment. We also require a two hundred dollars (\$200) Deposit for all vehicle rentals. We will refund you the full deposit within five (5) business days once there are no damages done to the vehicle.

CANCELLATION POLICY

You have ten (10) days to cancel a pre-booking at no cost. After ten (10) days of no-cancellation you will lose your full 20% down payment.

RETURN POLICY

Renter must return vehicle with same amount of fuel given, otherwise will have to pay the cost of fuel. Renter should return vehicle in same condition given, otherwise will pay the cost of any damages on vehicle.

RETURN TIME

Renter must return vehicle on or before the expired time and date stated on the contract. Renter has one (1) hour grace period. *Two hours after your grace period will be considered as an additional day added to your bill.*

N.B. ALL PERSONS DRIVING SELF-DRIVE VEHICLES MUST BE NAMED IN THE RENTAL AGREEMENT.
